PROHIBITION OF THROUGH TRAFFIC
TEMPORARY ORDER 2021**

THE ROAD TRAFFIC REGULATION ACT 1984 AS AMENDED BY THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991

NOTICE is hereby given that Doncaster Borough Council intend, not less than seven days from the date of this notice to make an Order under Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 because works are being or proposed to be executed on or near the roads and the effect will be to prohibit any vehicle from proceeding in those lengths of Wilsic Lane/Wilsic Road/Dadsley Road at Tickhill and Wilsic Road at Wilsic in the Doncaster Metropolitan District as described in the Schedule to this notice on the dates and times referred to in the said Schedule

Reason for closure: To ensure the safety of the public and the workforce whilst carriageway patching and repair works are undertaken.

NOTICE is also given that the alternative route for vehicles affected by the Order is via Castlegate, Church Road, Doncaster Road, Market Place, Northgate, Pinfold Lane, Rotherham Road, Wadworth Road, Westgate, Wilsic Road, Wong Lane

The Proposed Order will continue in force up to and including the 30th day of September 2021 or until the works which it is proposed to carry out in or near the said roads have been completed, whichever is the earlier.

Locations

- 1) Wilsic Lane, Tickhill from its junction with Peastack Lane to its junction with Wilsic Road
- 2) Wilsic Road, Wilsic from its junction with Wilsic Lane to its junction with Long Gate
- 3) Wilsic Road, Tickhill from its junction with Wong Lane to its junction with Peastack Lane
- 4) Dadsley Road to Wilsic Road Unnamed Road, Tickhill - from its junction with Dadsley Road to its junction with Wilsic Road

In the event of any engineering difficulties, inclement weather or due to the rise and spread of Covid, then this closure may be continued to a date when all works are complete. All works are to be completed by the 30th September 2021.
